His parents taught him to have a high commitment to faith and unconditional love for others. Dr. Thompson has served in ministry for thirty years, always sensing God's call upon his life. He directs and educates Chaplains at Atrium Health Carolinas Medical Center and Levine Children's Hospital in Charlotte, North Carolina in his role as the Assistant Director of Spiritual Care and Education.



#### Chaplain Harry Burns, MA, BCC

Chaplain Burns, is a Chaplain at Novant Health Presbyterian Medical Center in Charlotte, N.C. He has also served as a Community Engagement Specialist with the Community Engagement Department. Born and raised in Las Vegas, Nevada, she made history as the first in her family to go to college.
